Reports - Food Collection: Christine thanked those who helped with sorting the magnificent response to the appeal. Parishioners had followed closely the list in the newsletter of items particularly welcome. Christian Care and Faith in Action had expressed their gratitude, a large amount went to the Foodbank and 3 families were supported by Sister Catherine. A small amount remains which will be taken to Faith in Action. £10 was passed to Sr. Catherine.

Another year we might consider asking Canon if we could take items straight to the Hall and sort them there immediately and move the majority on quickly. It is too much to sort and house in one home.

Holocaust Memorial Service: Four of us attended and were very impressed, the service commemorated recent genocides as well as the 75th anniversary of Kristallnacht. Teresa will send a short item to Talkabout, including poems read by Kings College Junior boys.

Fairtrade Sale: was well supported and more than £240 taken, (double last year). Unfortunately the heating in the Church Hall was left on. It was agreed that a donation of £25 be made to the Parish towards expenses and as a gesture of 'justice'. **Action: Liam** It was noted that the diocese wishes to become a Fairtrade Diocese, and we are listed as one of the parishes which holds this status.

End Hunger Fast: This is an ecumenical and multi faith Lenten campaign to end hunger in Britain. Individuals and congregations are invited to fast during Lent as a witness to and protest against the realities of hunger in this country. They suggest various ways of fasting and publicising the campaign. We would look at the website www.endhungerfast.co.uk and look for a poster to display on our noticeboard and/or item for the newsletter.
