## **INFORMING OURSELVES**

The ethical activity suggested last month was to "consider changing our electricity suppliers to a more ethical company". Most members had failed to follow this up as they were unsure how to judge or to locate a suitable service provider. We will postpone this task to a later date when we may feel better informed on the issue.

This month we agree to use only recyclable paper for Christmas wrapping, and in particular to avoid using metallic paper. This advice may also be placed in the parish newsletter and in Talkabout.

**Prisoners of Conscience** – the parish event will be postponed until Easter as we have run out of time to do anything before Christmas. However, group members may wish to send cards to prisoners individually. For those members who wish to do so, Kirsty has a book "Christian Solidarity Worldwide" (an address book for the persecuted church) which she will circulate.

## **INFORMING OTHERS**

Homeless Sunday 27<sup>th</sup> January – a food collection held at all Masses, supervised by a rota of group members.

Charity of the Year: Three charities with parish links have been suggested for this coming year; a clinic run by the Sisters of the Sacred Heart in South Africa; a health clinic for Aids patients in S. Africa (where parishioner Siobhan Dooley is employed) and "Concerned Christians" a small charity run by Michael Dennehy (whose daughter is also in this parish) working in S. African townships. John and Kirsty will try to obtain more information relating to these charities by contacting the relevant people. Meanwhile, group members can give some thought to how best we can support and raise awareness of these within our parish.

**Parish Council AGM 2<sup>nd</sup> December:** Julie S. will cover for Kirsty who will be away from home that weekend. Kirsty has sent in her report.
